

These terms and conditions apply to all agreements between Stichting Bevrijdingsfestival Limburg and visitors of the event. By entering the location of the event you agree with the following terms and conditions.

The organisation is allowed to refuse or remove people who violate these terms and conditions from the event location.

1. Visitors must be able to identify themselves with a valid ID/passport at all times.
2. Visitors may be searched prior to and during the event. Those who do not submit to this may be refused entry.
3. It is recommended for adults to accompany visitors under the age of sixteen. In the case of children, make sure they have proper ear protection.
4. Alcohol under the age of 18 is prohibited.
5. Smoking is only allowed in the open air. Visitors who do not comply will be addressed by our staff and risk being removed from the event location. In case of drought, it is advised not to smoke on the event site.
6. It is prohibited to bring the following things to the festival site: pets, bicycles, audio equipment, (alcoholic) beverages, (hard)drugs, nitrogen monoxide (laughing gas), glass, tin, fireworks, plastic bottles, (firing)weapons, and other dangerous items. In case of possession of legal prohibited items such as fireworks or weapons, the visitor will be handed over to the police.
7. Stichting Bevrijdingsfestival Limburg has a zero tolerance policy for (hard)drugs including nitrogen monoxide (laughing gas). If drugs are found on a visitor, they will be confiscated immediately and the organisation may decide to deny the visitor access to the festival site or, if the visitor is already inside, to remove the visitor from the festival site. In case of possession of large quantities of drugs and/or suspicion/discovery of dealing, the visitor will be handed over to the police.
8. Photo cameras in any form are allowed. Photos can be taken from the festival site. Note, access to the photo pit is only allowed with the possession of a photo pass.
9. It is prohibited to wear club clothing as well as other clothing and expressions that can be perceived as provocative.
10. Selling commodities such as beverages, food, souvenirs, t-shirts, scarfs, flags and similar or offering these commodities for sale is prohibited. The spreading of promotion materials is only allowed when written permission of the organisation is granted.
11. It is forbidden to create any danger to property, life or health of oneself or others, or to cause any other kind of damage. This includes stage diving and the moshpit.
12. All visitors give permission to the organisation to take, reproduce, disclose and/or exploit video and photographic images by entering the festival site.
13. Consumption coins are only usable during the event.
14. Excess purchased coins can be returned at the cash registers until 11:59 PM (May 5). Costs will be charged for refunding the amount.
15. Instructions from staff of the organisation as well as police, fire brigade, GG&GD and other competent authorities must be immediately followed by the visitor.

16. Staff of the organisation as well as the police are always entitled to search the visitor for possession of unauthorised items and, when appropriate, to take these into custody or destroy them.
17. Everyone should inform themselves about the escape routes to be used in case of an emergency or threat at arrival at the event site.
18. Anyone acting in any way contrary to the provisions of these general terms and conditions may be denied access to the event site by employees of the organisation, or designated persons, as well as police and other authorised persons and/or organisations, without prior warning, or may be removed from (any part of) the event site, or handed over to the police.
19. Entry to and visiting the festival site is entirely at the visitor's own risk.
20. The organisation's liability is limited to the amount paid out by its insurer in a specific case on account of any damage or injury caused to visitors and/or visitors' goods. In situations not covered by these conditions, the organisation will decide.
